PUBLIC COMMENTS

Chris Peterson, resident at 213 Atlantic Avenue read a letter hereby incorporated into the minutes.

Maureen Dintino, at 317 4th Avenue N

- She is a newer resident to Kure Beach, and she bought her house about 2 years ago
- She does not see the reasoning in ripping out what is existing and how it will be cost effective or beneficial to the Town
- How much money has been put into maintaining the vegetation, bushes, and fence?
- The Town will destroy so many animals' homes and she believes the Town should keep what we currently have and maintain it

Tom Dintino, at 317 4th Avenue N

- He has been here a couple years and he appreciate all the Town employees
- He has more money in bicycles than you can imagine, and he tries to stay away from congested areas when riding
- He thinks it is not a good place to have bicycles and would restrict bicycles from being allowed on the boardwalk and only allow foot traffic
- He does not like bicycles on the beach and is not a fan of electrical bikes

Howard Ames, 313 Atlantic Avenue

- There are two main concepts the Town is trying to address regarding the boardwalk
- First is the overall condition of the boardwalk and second is the actual transportation of the boardwalk into a multiuse path for the expressed purpose to satisfy bicyclists
- In his opinion the two-block area does not meet the definition of the multiuse path per the NCDOT description
- It will also make the Atlantic Avenue area less safe for pedestrians and bicyclists
- Part of the reason the boardwalk was created was as a pedestrian path and a safe area for pedestrians
- The Bike/Ped Committee did ambilocal job creating the large plan but was misguided with faulty logic regarding the boardwalk
- Trying to combine two issues into one, and it does not work here
- One last thing to not forget is the filming industry which is greatly expanding in the area

Susan Sewell at 313 Atlantic Avenue stated:

• She just wants to say that she feels she has been threatened as a community and the Town has forced us to due diligence and we have uncovered more things than anticipated

- She is very frustrated and upset about this and has been working with the local office of the NC Coastal Federation and has become more versed in coastal preservation and stormwater runoff
- She has spoken at length with Johnny Griffin the Director at Wilmington Regional Film Commission, and he stated they chose Kure Beach because of the uniqueness and how you can walk along the boardwalk and see the Ocean
- A lot of the shows filmed are based in New England and this is the only place on the coast of NC that has the same look that is appropriate for where the show is set
- He stated if the boardwalk is removed or changed from the wood boardwalk while it wouldn't be enough to move a \$500,000 million dollar project to another state, they would not be filming in NC anymore
- Last year in 2021 was the best film year in Wilmington
- There is a petition going around that currently has 460 signatures which in the combined votes in the last election was less than 460 votes
- She has no desire to run for office, but this will be a thought during the next election

PRESENTATIONS

New Hanover County, Quarter-Cent Transportation Sales Tax

The New Hanover County presentation on the Quarter-Cent Transportation Sales Tax to Expand Trails and & Modernize Transit is hereby incorporated into the minutes. The presentation was presented by New Hanover County Staff.

Presentation Highlights:

- Referendum for a quarter cent sales tax to be used for public transportation systems will appear as a Yes/No vote on the November 8 ballot.
- Sales tax would be 25 cents for every \$100 spent on eligible goods by visitors, commuters & residents.
- Does not apply to items like groceries, fuel, and prescriptions.
- Could bring in around \$14 million a year and provide a sustainable source of revenue for public transportation opportunities, greater connectivity with trails and sidewalks, and increased safety for bikes and pedestrians.
- Funds could also be leveraged to receive additional state and federal dollars and amplified for a significantly larger investment in public infrastructure.

DISCUSSION AND CONSIDERATION OF DEPARTMENT HEAD BUSINESS

- 1. Finance Department
 - Fire Engine Purchase and Proposed Financing Terms

Finance Officer Copenhaver stated:

- Included in the agenda packet is a summary of the proposed purchase of a Fire Engine that was included in this year's budget
- He has received the proposal and it has been reviewed by the Fire Department
- His recommendation is to finance part of it and take into consideration a prepay discount the total cost of the fire engine is \$749,059 with a prepay discount of \$43,000, which would bring the net price to \$715,059
- The current lead time is about 2 years for the fire engine and his recommendation is to take advantage of the prepay option
- The whole expense is included in this year's budget, but also included 100% financing of the fire engine in the budget
- He is proposing instead of entire amount finance the \$425,000 of the purchase and take the rest from Town reserves
- He has solicited proposals and received from two different banks
- He is recommending approving the proposal with First Bank, financing for 8 years at 3.21%

MPT Oliver asked does the Local Government Commission have to approve this? Will they be okay with the prepay?

Finance Officer Copenhaver stated they do not have to approve this because the financing will be less than the \$500,000.

Commissioner Panicali asked is the 3.21% locked in?

Public Works Director Mesimer commented yes.

Commissioner Panicali gave a presentation of Dogs on the Beach hereby incorporated into the minutes.

MPT Oliver commented he appreciates the presentation by Commissioner Panicali. He thought the citizens who brought this forward were very respectful and had a very passionate appeal asking Town Council to amend this ordinance. He has seen citizens bring dogs to the beach during the hot hours of the day which really bothers him. He has spoken to citizens and he is not sure which way to go as there was no clear feeling. He does not have a problem with amending the ordinance but unsure how to amend it.

Commissioner Panicali stated because of the parking restriction a lot of citizens do not come down till after 5:00 p.m. Enforcement is an issue and it is why Carolina Beach hired the beach rangers to help write the citations. He has received about a dozen emails mostly in favor of changing the ordinance from citizens.

Commissioner Ellen stated he does not think it is fair to the dog and it is the persons interest and not the dogs. The dog does not care where it walks, and he truly believes that.

Commissioner Panicali stated he disagrees with Commissioner Ellen. His dogs love the beach and enjoy playing in the waves. If you walk your dog on the street, you will see lots of signs saying do not walk your dog in my lawn and the streets are also hot so it can be difficult. He does agree that no one would want dogs on the beach during the daytime as it is not safe.

Mayor Bloszinsky commented during the season he is not a fan of dogs on the beach. He is more worried about the downside than the benefit side.

Commissioner Heglar commented he loves dogs and he has 3 dogs. His wife would love to be able to take them down to the beach. He does not have a strong opinion either way. He thinks the Town will be fine either way. There is a mix of opinions from the citizens.

213 Atlantic Ave. Kure Beach, NC July 18, 2022

Gentlemen of the Council:

In mid June, we received the notification letter to abutters on Atlantic Ave., that the Town was applying to CAMA to replace the boardwalk with a 10' wide, ground level, concrete sidewalk, and in the process deleting the planted bed that has been a necessary and effective buffer to the roadway. We were shocked and dismayed!

The specifics in the application completely misrepresented the considered vision of the community at large, as regards the two block boardwalk, and included in the Bicycle/Pedestrian Master Plan. In that Plan is the declaration of the Boardwalk's importance to the community, and I quote,..."one of Kure Beach's most recognizable and iconic features". Also in that Plan, the maintenance concerns were well vetted with suggestions of upgrade materials etc., as a guide. You totally ignored that guidance. Rather, you chose to base your application specifics on the request of the maintenance crews, that it be a concrete sidewalk???

Your actions and feeble explanations forced our response into an adversarial mode; to do our own due diligence because you failed to do yours. That's no way to conduct town business!

Further, if the need to rush was because of a valid reason to beat some deadline, you should have involved the community by simply calling a special meeting. There was time! So easy and so appropriate! Your actions blatantly defied the tenet of transparency in Governance.

In Mayor Bloszinsky's letter to the community, he writes of clearing the air with better communication. I respect that. But several of his pronouncements as to your intended next steps give me further concern.

In his opening sentence he states your intent to 're-engineer the existing boardwalk.' What happened to your explanations that your actions were driven by the need of repairs and maintenance? The Mayor mentions twice of your intended next steps...'to develop a specific Plan;'...'an inclusive Plan', then presenting it for community input and discussion—afterwards.

I quote again:...'the Boardwalk belongs to the entire Town so that Plan will go to the community for comment using a Charette process, a collaborative planning process.' With all due respect your intent is backwards! I am a fan of the Charette process. I have been privileged to participate in that collaborative process several times in my community involvement elsewhere. FIRST you have sufficient discussions and input from all interested parties. Only then do you draw up a Plan which in turn can be used, as needed, for more future

I would appreciate it greatly if you could read the following statement into the record at the Town Council Meant this evening.

Thanks - Terry McHugh

We appreciate the letter that the Mayor has recently posted on the Town's website regarding the Atlantic Ave boardwalk. While his letter did clarify several matters, we remain opposed to the proposed 8 foot wide concrete sidewalk along Atlantic Ave between L Ave and N Ave.

A multi-use concrete sidewalk will create a dangerous environment. Families with strollers and young children on their way to the park or pier; those carrying surfboards and boogie boards,; and beachgoers ladened with chairs, umbrellas, tents, coolers and kids would now have to avoid the bicycles, scooters, skateboarders and hover boarders utilizing a narrow ribbon of concrete.

The current width of the boardwalk accommodates pedestrian traffic quite well and does not require widening. The only "choke points" we have observed is where the vegetation along Atlantic Ave is allowed to extend over the boardwalk. This is a landscape maintenance issue that should be addressed by the Town

Atlantic Ave is a low speed, one-way street. Cyclists are able to negotiate safely along the road in either direction without difficulty and without creating a dangerous situation with pedestrians using the boardwalk.

"Improvements to the oceanfront boardwalk, we didn't want to talk about that tonight. Okay, now, ladies and gentleman, please listen to why we are where we are - John".

John Batson: "The other big question I kept hearing about was safety from pedestrians and cars coming down the road um, in all of are talks so far there has been a lot of discussion about placing bollards about every 6 feet down the road so uhh so cars being able to access that walkway would certainly be possible if they wanted to tear their car up but ultimately would be a deterrent."

According to statements made by John Batson in the public meeting with all of town council present (one member virtually), it is apparent that discussions have occurred in regards to addressing safety concerns with the proposed "ground level" sidewalk by placing bollards every 6'. This fact was omitted from the CAMA Minor Permit Application #22-05 which requires the applicant to list ALL proposed construction and land disturbance. The application also states the following:


This application includes: general information (this form), a site drawing as described on the back of this application, the ownership statement, the AEC hazard notice where necessary, a check for \$100.00 made payable to the locality, and any information as may be provided orally by the applicant. The details of the application as described by these sources are incorporated without reference in any permit which may be issued. Deviation from these details will constitute a violation of any permit. Any person developing in an AEC without permit is subject to civil, criminal and administrative action.

We have recently been made aware that the Town Council of Kure Beach is considering a concrete path (with ballards) to replace the iconic and beautiful boardwalk. As a frequent visitor to Kure Beach, we want to let you know our opposition to this plan.

The current boardwalk is lovely to look at and a pleasure to walk along and view the ocean. It is enjoyed by families, groups and singles (and pets) who stroll together on their way to the pier and the pavilion. Replacing the boardwalk with concrete will be an eyesore and Kure Beach will lose much of its beach town atmosphere. The boardwalk is a big draw to Kure Beach, and it is enjoyed by everyone.

Replacing the boardwalk with a concrete path at street level may be an environmental disaster. Water from tropical storms or hurricanes could cause greater flooding, and the fragile dunes would be exposed to more erosion. At the least, an environmental impact study is needed before moving forward with a significant non-pervious surface.

A wider path to accommodate walkers and bikers is not necessary, in our opinion. Presently, walkers do not have to worry about bikers coming up behind them, hitting them, their children or leashed pets. Atlantic Avenue is a one-way street with a 15/mph speed limit, which is perfectly fine for cars, golf carts, and bicycles to share. We have stayed ocean front on Atlantic Avenue several times, and we have never seen a problem with bikes sharing the road with vehicles. Atlantic Avenue is not congested, even at the busiest times of the year. (Bicycles should not be allowed on the boardwalk, and we rarely see anyone trying that.)

We always enjoy a few strolls on the boardwalk when visiting Kure Beach. A total tear-down and replacement with a concrete path is a bad plan the town vibe and for the environment. There are other options for repair and maintenance of the boardwalk that should be considered. Save the Kure Beach Boardwalk!

My name is Diane Webster. I am a co-owner of 301 Atlantic Avenue in Kure Beach. This house has been in our family since 1973 and is on the Federal Point Historical Registry. I write to this Council to express my vehement opposition to the proposal of changing the wooden boardwalk into a dangerous, impervious concrete 8 or 10-feet wide bike path. It has not been made clear to me why this proposal is even being made. Although I see references being made to the cost of maintenance, (a foreseeable expense when it was built) there are also references to alleviating traffic on Ft. Fisher Blvd. and to catering to bicyclist. So, I would like an explanation as to the reasons for even considering this unnecessary, expensive, and dangerous plan.

I have spent countless days observing the use of the current boardwalk. It is primarily used by people walking, often with their children and using strollers. The idea of having bicyclist weaving around walking adults and children on this proposed bike path is beyond scary. It's a train wreck waiting to happen. I have nothing against people who want to ride bikes on Atlantic Avenue. They often do this and I have never seen any problems with bikes and cars sharing the road. However, pedestrians sharing a lane with bicyclists, while vehicles are at the same level, is clearly dangerous.

There are many, many other factors, besides safety, that dictate that this proposal should not be approved by the Town Council.

Excess water accumulation, which already occurs at the intersection of Atlantic Avenue and M Avenue after a thunderstorm;

Impact on our beautiful dunes that have taken many years to form;

Bollards to separate the street from the pathway would look hideous!

People rent on Atlantic Avenue precisely because it is a tranquil, oceanfront area conducive to taking a stroll, not to watch a parade of vehicles, bicycles, and pedestrians all trying to avoid each other.

The Town will lose income from summer rentals if it proceeds with this plan as it will ruin the aesthetics of the area. If growth is the reason for this proposal, what studies have been conducted on the saturation point of the town from increased visitors? Will the town need to increase its insurance for the inevitable law suits resulting from injuries at the site?

I could go on and on as to why this plan should be rejected, but I won't. Please, please, reconsider moving forward with this project that is so dangerous, that is so visually unappealing, that will cost so much money, and that is in contradiction to the Kure Beach Land Use Plan.
