New crosswalk at Surfrider Ct.</p> <p>The other crosswalks will be engineered by TransSystems and Town has agreed to pay any amount over \$250,000.</p> <p>Crosswalk at Ft. Fisher &amp; K Ave. is under environmental review—there used to be a gas station there.</p> <p>CM asked that the bushes along sidewalk on east side of Ft.
