Mayor Bloszinsky called the meeting to order at 4:00 p.m.

The purpose of this special meeting is to continuee discussion of the Premium Parking Management Agreement.

MOTION- Commissioner Whitley made a motion to continue the Special Council Meeting from February 12, 2021 to discuss the Premium Parking Management Agreement. SECOND- Commissioner Ellen VOTE- Unanimous

#### **RESIDENT PROGRAMS AND COST:**

Commissioner Oliver commented he would like residents of the town to be able to park for free.

Commissioner Whitley stated residents would not be forced to purchase a parking pass.

MPT Heglar stated he believes there should be a fee as staff will need to verify resident passes.

Commissioner Ellen stated he believes there should be a fee but is open to the amount.

#### Judy Larrick - Settlers Lane

• She stated she is under the impression that the re-entry sticker would be used for paid parking as a resident. She does not want to have to purchase the parking pass.

Mayor Bloszinsky stated the stickers are strictly for re-entry purpose for an emergency only. The Town will be using a license plate recognition system. No citizen will have to purchase the parking pass.

#### Dennis Panicali – Parking Committee

 Premium Parking allows for flexibility on the registrations. How many license plates, how to document, etc. The Town's responsibility would only be for the residents who do not feel comfortable doing this online.

#### Jay Stuart - 742 Cutter Court

• Is this going to be 365 days per year? He does not need to park during the season but would like to use spaces for the off season.

MPT Heglar advised that paid parking would only be during the season from April 1<sup>st</sup> – September 30<sup>th</sup>.

Mayor Bloszinsky asked what about additional passes?

CONSENSUS: Town Council agreed residents will have to pay the seasonal rate of \$200.00 for any additional cars beyond the 2 parking passes.

#### **RECREATIONAL:**

Recreation Director Keely stated attendance fee does not work across the board she suggestions the following:

- Allow vendors for market to park as part of the vendor fee
- Coupon code or license plate entering

Facility rentals – brings in large group. do we want to consider a certain set number of coupons which each rental?

Dennis Panicali stated Premium Parking provides a portal; license plates can be entered by the town daily.

CONSENSUS: Council will work with Premier Parking to come up with coupon system for vendors, facility rentals and recreation events.
