## DISCUSSION AND CONSIDERATION OF COMMITTEE BUSINESS

## 1. Bike Ped Committee

Commissioner Oliver commented:

- Tomorrow morning at 10:30 a.m. the Committee will hold the kickoff meeting with Alta with the WMPO for the Master Bike/Ped plan. Town Council is invited to attend the meeting
- Chairman Lindquist will attend the Bike/Walk NC in person, but the rest of the Committee has signed up to virtually attend in November
- The CRSSAA Grant for the Town will be voted on this week but has already gone through two recommendations for the Town's request of \$425,000 and the amount is about \$358,000 that they have requested
- The Committee will need to advertise for another member of the Bike/Ped Committee as a member has resigned

## 2. Historical Preservation Commission

#### Chairman Galbraith stated:

- The Commission is requesting some feedback/approval from Town Council to contact property owners in Town that are outside of the Historic District boundaries and recommend receiving a plaque form the Federal Historic Preservation Society
- The Commission will be holding a quasi-judicial training in January once the Commission fills the vacancy position
- Several members on the HPC feel the need to extend the boundaries of the Historic District as there are several homes outside the district the HPC would be interesting in preserving
- The Commission would like to do more research and bring back a formal recommendation

Commissioner Whitley commented he supports sending out the letters.

Mayor Bloszinsky stated he supports the letters to property owners as well and he supports HPC to do more research on the extension of the Historic District.

Commissioner Oliver stated he supports them doing more research.

# 3. Land Use Plan Committee

Commissioner Whitley commented Chapter 4 of the plan has been completed. The Committee will hold a public input session in February.

Mayor Bloszinsky commented paid parking is over for the season and once he receives the final numbers he will send out a note to the citizens.

Mayor Bloszinsky commented the Town has prepared a resolution for discussion tonight. He received a note from a resident recommending the Town request more mileage. The newer wind turbines would be larger by the time of the install. He is not opposed to alternate forms of energy but would like to not be able to see them.

Commissioner Ellen commented the Town Council could recommend a longer distance.

#### DISCUSSION AND CONSIDERATION OF NEW BUSINESS

1. Discussion of Electric Bikes in Kure Beach

Mayor Bloszinsky commented this item has been brought forward from a resident who was concerned regarding electric bikes on the beach strand as the speed can be significant.

# Attorney Eldridge stated:

- He is unsure what policy Town Council will decide on this issue
- If the discussion is to move forward in this direction, Town Council can prohibit all vehicles or allow some vehicles at certain parts of the day
- This is just his personal input and has no reflection on Town Council's authority to set policy but if he lived on the beach, he would personally want to be allowed to ride his non-motorized bike on the beach strand for exercise
- Does Town Council want to allow this?

- Several years ago, Town Council adopted the code provision included in the agenda packet
- It would be an easy fix to tweak this provision whichever way Town Council decides to go
- Based on some discussion it is his understanding Town Council may want to ban all sorts of vehicles, so he would recommend dropping the word "motor" in the title
- Vehicles on the beach strand are already prohibited in the Town Code, with a few exemptions and currently have regulations for the vehicles that are allowed on the beach strand
- He would add a definition of "Vehicle" as presented in the agenda packet

Commissioner Oliver commented he has requested what other beach communities are doing regarding electric bikes and has not received this information. He would like to receive that information before deciding. The Town has a Bike/Ped Committee that has been researching bicycle safety. He would like the Committee to continue through the process of the Bike/Ped master plan and give them the opportunity to do research and bring forward a formal recommendation.

CONSENUS- Town Council agreed to let the Bike/Ped Committee research electric bikes and bring forward a formal recommendation
