1. Public Works Department

Public Works Director Mesimer stated he is requesting Town Councils guidance tonight on how to proceed with the pipe underneath Town Hall. The quotes are included in the agenda packet. The price of materials are increasing constantly and would like to finish the project before the next hurricane season. He has reached out to the manufacturer and there is a 5-year warranty on the materials and installation. He recommends proceeding with the project.

MPT Heglar commented Bill Bryant did estimates as he is a retired professional engineer on the actual impact of the lining and how it would increase the flow. There is a 36-inch pipe that goes underneath Town Hall to a ditch on K Avenue and takes stormwater to multiple neighborhoods underneath Town Hall. The concrete pipe is about 30 years old and the Public Works Director Mesimer contacted experts who recommended slipping inserts of fiberglass.
