Mayor Bloszinsky called the meeting to order at 6:00 p.m. and Commissioner Ellen gave the invocation and Pledge of Allegiance.

1. Bike Ped Committee

Bike/Ped Chair Linquist:

- The draft Bike/Ped Master Plan comments are being received till March 28th
- Last week a few members of the Bike/Ped Committee and MPT Oliver met with the NCDOT to receive more input on the lighted crosswalk signs
- The Committee addressed issues on adding additional crosswalks farther south in Town and the NCDOT was great to work with on this potential project
- The Bike/Ped Committee will be hosting the Traffic Garden Event on April 9th to teach children about road safety
- The Island Women will be volunteering at the event and if any citizen would like to volunteer please let the Committee know

2. Board of Adjustment

3. Historical Preservation Commission

• Discussion of allowing Students to do Community Service Hours for HPC to create an inventory of homes built before 1972 in Town

HPC Chairman Galbraith commented he was approached by a few high school students who would like to complete service hours for the Town. One of the items the Commission is working on is identifying historic properties in Town. The Town does not currently have an updated list of all the Historic properties throughout Kure Beach. The Commission was thinking the students could earn service hours by creating a list of the Historic buildings that are older than 50 years by driving around Town and then checking the deeds of the property.

Mayor Bloszinsky asked what risk would the Town have if any person got hurt?

Attorney Eldridge commented that would be covered under the hold harmless agreement each student would be required to sign.

4. Land Use Plan Committee

Chairperson Galbraith stated the Committee will meet this Wednesday with the Council of Government.

5. Planning and Zoning Commission

Continued Discussion of 6 Foot Fences in the Side Yard

PZC Chairperson Galbraith commented a proposed text amendment regarding fences in the side yard was brought forward to PZC and the Commission recommended that Town Council not approve as presented. He spent some time doing research that he presented last month regarding what other similar Towns ordinances are for side yard fences. The PZC at the last meeting felt that the Sunset Beach ordinance would be acceptable. Rather than using the property line use the building. The Commission also thought that if the property is adjacent to a commercial building than it would be acceptable to have a 6-foot fence.

6. Shoreline Access and Beach Protection

 Discussion of Sea Oats to be placed on new Sand Dunes near Ocean Dunes (Chairman Panicali)

Chairman Dennis Panicali commented:

- The Committee is requesting for the Town to purchase sea oats near Ocean Dunes
- The dunes that were instructed recently were donated by Bledsoe construction which was around 1,500 feet total
- The downside is the area is prone to erosion, but worth while to stabilize the dunes
- If purchased Bledsoe construction has volunteered to install the sea oats

MOTION- Commissioner Heglar made a motion to purchase Sea Oats not to exceed \$9,000 from account designated by the Finance Officer for the Ocean Dunes area

Commissioner Heglar commented the Committee is still waiting on the state to update the permit renewal approval. He is requesting permission for the Public Works Director Mesimer and himself to work with an engineer to receive quotes for reviewal and approval of stormwater permit transfers as these will now be done by Kure Beach instead of the state.

CONSENUS- Town Council authorized Public Works Director Mesimer and Commissioner Heglar to work with an engineer to receive quotes for review and approval of Stormwater permit transfers

Town Clerk Sanders stated:

- She received a request from the Little Pink Houses of Hope/The Island Men to receive free parking for 12 families and 5 volunteers for the week of April 24th-April 30th
- The Town sponsored them last year by allowing free parking for one day but the request this year is for the whole week to be able to do family portraits throughout the entire week
- Kure Beach Baptist Church has also requested free parking to hold blood drives in April, June, and August during the paid parking season which will be alternate months from the Community Center
- The first blood drive would be held on April 18, 2022 and the church is requesting 15-20 spaces from 8am to 5pm
- The church would provide the signs for the free parking
- The last item is she would like to request that for Public Information Sessions and Legislative Hearings to no longer use the call option unless an individual submits a special request to have the call in information available

MPT Oliver commented he would like to remove remote participation for all meetings moving forward and return to the pre Covid way of handling meetings. The building is ADA accessible and he would rather the public attend the meetings in person as it is easier to hear.

Commissioner Ellen stated he agrees with MPT Oliver.

Commissioner Heglar commented that is not what Town Clerk Sanders is requesting at this time. Can the Committees still have the option to call-in?

Attorney Eldridge commented the Committees can still use the remote participation under the State of Emergency the Town is under.

MPT Oliver stated maybe the Town Council needs to review this next month after reviewing all the options possible.

Mayor Bloszinsky commented he would like time to review the information and hold conversation on it next month after hearing the options.

Building Inspector Batson commented:

- The Beach Nourishment Public Information was held last Monday and since then received an update that from J Avenue to Davis will be receiving sand
- The projected date to start is still March 27th for Kure Beach and completed by April 30th

- The contractors were at Davis Beach Road this afternoon placing mats to protect the hazardous ramps
- Regarding the original text amendment that PZC denied recommending at the last months PZC meeting there was a lot of discussion
- The Applicant has since submitted a new amended text amendment that is included in the agenda packet tonight
- The amendment reads "Side yard fence may be raised to 6 feet in height when unusual property circumstances exist such as nonresidential uses or public parking is adjacent to the specific property/lot line in question"
- This certainly helps the applicant and other properties in Town, and he believes it is better than what is currently in the Code
- He does feel the original text amendment was more evenly applied across the jurisdiction and that everyone was treated the same regarding house placement, but he is glad to see some changes

MPT Oliver asked how far up the side yard would the applicant be allowed to put the fence?

Building Inspector Batson answered the way this reads the entire property line.

Commissioner Heglar commented wouldn't it be to the front of the property based on the definition of the side yard. Would the applicant be allowed to go to the front yard setback or to the side of the front part of the property?

Building Inspector Batson stated to the front yard setback.

MOTION- Commissioner Heglar made a motion to approve the amended proposed text amendment to Chapter 11 - 11.14.010 Restrictions (Exemptions) as presented SECOND- MPT Oliver VOTE- Unanimous

3. Fire Department

Fire Chief Kennedy stated:

- Building Inspector Batson and himself have worked to put several quotes together regarding tearing down and rebuilding the lifeguard shack
- After receiving several quotes for all parts of the project the final estimate is \$47,000 which includes the engineer plans but does not include the 20% contingency on materials
- He is requesting Town Council approval so the project can be completed within the month

Building Inspector Batson commented he wants to make sure Town Council is aware that Fire Chief Kennedy and himself will be acting as contractors to the Town. He will have the Carolina Beach Building Inspector review the plans and handle the permit and inspections. There will also be a dumpster downtown and Town staff will be blocking 5 parking spaces to complete the work.

MOTION- Commissioner Heglar approved the Budget Amendment 22-08 in the amount of \$47,500 for the replacement of the Lifeguard Shack SECOND-MPT Oliver VOTE- Unanimous

4. Public Works Department

Public Works Director Messimer commented Civil Solutions finished the project for the pipe last week at Town Hall. Civil Solutions will be coming back to camera other parts of Town in the future.

Mayor Bloszinsky commented he spoke with the Beach Walk HOA and the HOA is very pleased with the work completed by Civil Solutions.

Greenway Ext to Town Hall

(Comments to KB Town Council, 3/21/22)

Tonight you will hear a presentation by Alta, for WMPO, on the Draft KB Bicycle & Pedestrian Plan. This plan includes proposed bike paths (so-called Greenway) in Motsu fire break land behind Settlers Lane to Town Hall (p. 12,13) as well as an extension to Fort Fisher. Since only one Council member remains today from 2004 when WMPO first presented this same bike path to KB Council, I want to remind you of the actions and concerns at that time. Approx. 50-75 KB residents showed up in opposition to this proposal behind our homes because of issues of security, safety, privacy, environment, wildlife, costs, lack of police presence, and potential fire hazards. The Council, Police Dept and Fire Dept unanimously agreed and rejected the path. It was revisited again in 2010, 2014, 2016 with the same result. But it was approved, and later built, by CB. However before construction, even the Town of CB relocated the original path away from behind the homes in Carolina Sands due to the resident's objections and concerns.

And today, the majority of residents along Settlers Ln in KB Village, Keys, and Beach Walk are still opposed to this path and, yes, "passionately express our concerns". We also are opposed to Settlers and other neighborhood streets becoming designated bike routes, funneling riders onto a few streets, rather than embracing and acknowledging all the neighborhood streets available to bikers in KB. It's easy for many people to be in "favor" when it does not directly impact their happiness, property, privacy, safety, well-being or taxes! In 2004 and still today, the most logical solution is an OFF-ROAD (And I emphasize Off-Road) Bike Path along Dow Rd right-of-way connecting from CB State Park off-road bike path to KB Joe Eakes Park on K Ave. There were significant numbers of people at the public meetings in favor of this option as well. It provides the same desirable connections to "destinations north and south along the island" as stated in this Draft. It is not, however, given consideration in this draft as it's "less viable due to current Motsu restrictions of use" (p.14). Yet the same "Motsu restrictions of use" exist behind Settlers, in Ft. Fisher as well as all Motsu land. In my opinion, WMPO has never even seriously pursued or considered this option.

This draft further proposes a bike path Extension (p.14, 15) to Fort Fisher again shown through Motsu land from Seventh Street, through FF Air Force Recreation Area (FFAFRA) to FF State Historic Site. However, FFAFRA land is owned, not by MOTSU, but by Seymour Johnson Air Force and the NC National Guard, while NC State owns the Historic Site land. And again in 2004 both FFAFRA and the Historic Site adamantly declared to WMPO that their land could NOT be accessed with a bike path.

With this bike path frequently revisited in the past 18 years, I believe it's time to put it to rest permanently. This area behind Settlers is maintained by Motsu as a fire lane and should remain a fire lane, not a fenced in bike path. How then could it possibly function in the event of a fire? Last year, for the first time ever, Motsu, in response to the Town's concern for fire risk, cleared not only the fire lane as usual, but most of the vegetation and trees on the east side behind the homes on Settlers negatively also impacting flooding issues. This draft recommends "native landscaping and trees" to provide privacy, but it's also too late for that now! In addition, the Town is also aware of other issues with this land including wet lands flooding, remains of the old Dow plant, costs, etc. I don't know the legal responsibilities for a bike path Plan approved by KB Council, but it certainly seems to me inappropriate for the Town to approve plans for land they do not own. Therefore, I believe the "Island Greenway Extension to Town Hall and Extension to Fort Fisher" should both be eliminated from this Plan entirely and put an end to these endless discussions.

My name is and I am here tonight to speak on behalf of the Kure Beach Pickleball players, a group of 85 plus PB enthusiasts who play on a daily basis at Joe Eakes Park. The KBPB group is a welcoming group comprised of players of all skill levels. Our player base consists of Kure Beach and surrounding area residents, vacation owners, and tourists.

Pickleball is the fasted growing sport in America. It is fun, social, and easy to learn. It is one of the only sports where the whole family from kids, to parents, to grandparents can play together and

have a blast. In the past four years we have witnessed this same growth and enthusiasm for Pickelball at Joe Eakes Park.

Due to having to share court space with tennis and basketball players our court space is limited. Although we have access to 5 courts due to the number of nets we have, we are guaranteed only access to two courts. The basketball courts where we play most of our games are not ideal for Pickleball. The rocks surrounding the courts are trip and fall hazards and the sand from the dog park and bleacher area are slip hazards.

The town of Kure Beach through the Parks and Rec Dept. is actively seeking ways to grow the sport. We applaud their efforts and strongly support any plan that would grow the sport in our area. Unfortunately Pickleball growth at Joe Eakes Park would be hindered with our current limited court situation.

Therefore we stand before you tonight requesting the Town of Kure Beach add three dedicated Pickleball Courts to allow the vision of the Town and the enjoyment of the KEBP players of be recognized.



We are aware of the License agreement with MOTSU and the challenges involved to make changes or improvements to the park. Carolina Beach did some major improvements to their dog park and added two targe utility buildings at the Mike Chappell Park, a MOTSU licensed park in the past year. If CB can go thru the protocols and procedures to make improvements to their Park why can't we?

Wrightsville Beach just approved the addition of 5 dedicated Pickleball courts using a PARTF (Parks and Recreation

Trust Fund Grant) If WB can go thru the application and filing process to secure grants, why can't we?

We have identified the ideal location within the Joe Eakes Park campus for 3 disturbed dedicated Pickleball courts. 

- Provides a safe way for pedestrians & cyclists to travel north to south in Kure Beach, while avoiding Fort Fisher Blvd






Project: Island Greenway Extension to Town Hall/K Ave

If built, this trail should:

- Aim to preserve the natural feel of the corridor; construction of the existing Island Greenway north of Kure Beach had a wider footprint in the construction process than may be necessary;
- Be designed to decrease rather than increase currently reported drainage issues;
- Be designed to add native landscaping and trees between the trail and homes to provide privacy (some homes do not currently have privacy or landscape screening from the corridor);
- Be designed with mile-markers for safety and wayfinding; and
- Have a well-defined and adequately funded maintenance and management plan in place.








