MOTION - Commissioner Dugan made the motion to add one additional item "Memorandum of Understanding between Carolina Beach and Kure Beach for Building Inspection services for construction of the Ocean Front Park.

- 3) Memorandum of Understanding (MOU) between Carolina Beach and Kure Beach for Building Inspection services for construction of the Ocean Front Park
 - Mayor Lambeth stated:
 Building Inspector Batson has been talking to firms about services to provide special inspections for the construction of the Ocean Front Park. This is at the request of the Carolina Beach Building Inspector who is issuing the building permits. Cost is around \$20,000.
 - The Carolina Beach Building Inspector has also said we may have to move the handicap ramp.
 - I told Building Inspector Batson we needed a meeting with Commissioner Dugan, both Building Inspectors, the architect and Engineering Services to discuss these items.

Discussion points were whether this is necessary, whether it had to be approved today, whether some of the Carolina Beach Building Inspector's requirements were necessary, and whether the County should do the inspections.
