MOTION- Member Young made a motion to appoint Member Moore as the Vice Chairman of the Historical Preservation Commission SECOND- Chairman Galbraith VOTE- Unanimous

## C. Adoption of Rules of Procedure

Attorney Eldridge stated these rules of procedure are mirrored after the Kure Beach Board of Adjustment rules of procedure. Most of it is standard procedure as the commission has already confirmed the regular meeting schedule. If nothing is listed on the agenda under these rules, the Commission cancels the meeting with 24-hour notice before the scheduled meeting. On page four, subpart B regarding applications for a COA the application has to be reviewed, heard and acted on within 60 days of the application being filed. The commission may want to shorten the period to 30 days but does not recommend anything less. There is 10 to 25 day notice requirement.

Chairman Galbraith stated he believes the Town Council wants us to act quickly so recommends 30 days.

Vice-Chairman Moore commented he has some concerns regarding the short period.

MOTION- Chairman Galbraith made a motion to approve amending the rules of procedure from 60 days to 45 days SECOND- Vice-Chairman Moore VOTE- Unanimous

MOTION- Member Young made a motion to adopt the rules and procedures as presented with the amendment of 45 days for the Historical Preservation Commission SECOND- Chairman Galbraith VOTE- Unanimous

Chairman Craig Galbraith stated he recommends using the presented model before the Commission from the *Raleigh Report and Recommendation for the Designation of the South Person/South Blount Historic Overlay District* as a model for the HPC to follow. He recommends that the commission do the first draft of the plan without a consultant. He would be willing to speak with the UNCW History Department, as his son is a history major. He might be able to initiate a descriptive section on the history of the district and bring it back to the commission next month.

MOTION- Vice-Chairman Moore made a motion to adjourn the meeting at 6:42 p.m. SECOND- Member Young VOTE- Unanimous
