OLD BUSINESS:

A. Form-based planning

- Chairman Galbraith presented information regarding form-based planning that he acquired through research. He found Town of Ft. Myers Beach which is one of the best.
- Beach community, promotes tourism and increase tourist economy and is good example of formbased planning.

- Basically identify what is covered by form-based planning on the map and then put together design standards for each category, condos, townhomes, signs, etc. Standards can be strict, very loose design standards. Identify architectural design you want.
