- 1. Turtle decals: These seem to be staying on the garbage cans. They will be continued to be monitored.*
- 2. Crossover construction permits: John Batson has not been able to get back to Tom. Presently the rule is apparently 1-½ feet above the existing dunes.*

- 5. Town's Beach Ordinances: Sandra Cox and Dick Graham have devoted considerable time to this project. Sandra has reviewed the ordinances and has drawn up several new ones that would be beneficial to the town, also revisions for several existing ones.*
  - a. The applicable fines should be increased.*
  - b. There is a need for a person designated as the Enforcement officer to follow through and ticket those who break the rules.*
  - c. Many of the ordinances are duplicated, but with different rules.*
