### OLD BUSINESS:

- 1. Parking Map (TDA). The map is up and running and can be located on the Town web site. The committee is monitoring and updating the map.

- 3. Coral Parking is still in progress.
- 4. The encroachment process for the new parking on K is in progress.
- 5. Beach Access Wood signs are in progress and the committee is waiting for a sample of how the wording on the signs will look.
- 6. *E through J beach accesses. The committee would like a study regarding the size of vehicles parking in Town. A problem has arisen regarding oversized vehicles causing disruption for handicap parking and regular vehicle parking.*
- 7. Goals. The goals for the balance of 2012 and the start of 2013 have not changed.
- 8. We have received the new wheelchair and it is being used when needed.
- 9. The new crosswalk has be completed

### NEW BUSINESS:

a. Wheel Chair fund Raiser: Tony has met the group handling the "You've been flocked" program who are raising money to obtain additional wheelchairs for the beach. They discussed the best type of wheelchair for the beach. In the past PVC construction for wheelchairs have been used and found have a short life span. The present wheelchairs we use are stainless steel and our existing chairs are several years old and still in excellent condition.
