Sea Oats

-This is not a SLABP matter, or something SLABP can budget. The issue has been posed to town Council.

Committee Chair/Co-Chair

-The Town Council Liaison to the committee has resigned and SLABP committee chair Dennis Panicali has applied to fill the vacant seat.

-If chosen, the SLABP will need a new chair, and a co-chair which is not currently assigned.

Public Input

-Dan Dixon used the call-in option. He said he is an Ocean Dunes owner and wanted to know how the committee defines "Protection." He was directed to the Town of Kure Beach website and the SLABP mission statement.

-Jean (did not get last name) was also on the call-in line and is also an Ocean Dunes owner. He expressed concern over people cutting through the dunes and wanted to know if there could be street facing "stay off the dunes" signs. Chairman Panicali said that signs would not be put in, but if spot is identified where people are cutting through and wearing down a path in the dunes, that would be addressed.
