- Our committee's role is to advise visitors and the convention bureau in Wilmington.
- We are working on a design for a website for the beach towns and Wilmington.
- Our committee's main goal is to get more people here to put 'heads on beds' and keep Kure Beach from losing it's identity and being lumped in with other towns.
- The next committee meeting will be March 11th with Clean Design. Everyone is welcome.

2. Shoreline Access and Parking (SLAP) committee

Joe Eakes Park

SLAP committee chairman, Tony Gonsalves, stated the parking layouts Joe Eakes Park and the Corral were received from Withers and Ravenel. The Police Chief and Public Works Director like the layout for Joe Eakes Park. Director Beeker wants a fence in front of the basketball court for protection. I am asking Council to approve the layout and adding a fence. The cost of the fence can come out of SLAP's budget.

Discussion:

Public Works Director Beeker suggested putting in the bumpers after the Street Festival. He stated an eight to ten foot fence with wings is needed and he will get a price.

Commissioner Swearingen asked if there will be landscaping.

Chairman Gonsalves replied that he is not in charge of landscaping. That would be the Beautification Committee.

Mayor Lambeth stated we didn't allocate money for landscaping.

MOTION – Mayor Pro Tem Keener made the motion to accept the parking layout plan for Joe Eakes Park as presented.

SECOND - Commissioner Nelder

VOTE - Unanimous

The Corral

Chairman Gonsalves stated the parking layout for the Corral has three concepts. Everyone agrees with concept # one that allows RV parking in the Corral. I recommend removing the wooden fence and planter in front for maximum parking spaces.

I want Council's approval to contact DOT to have the entrance to the Corral off K Avenue to minimize congestion on 7th Street for the Fire Department.

Lighting in parking areas in Joe Eakes Park and the Corral

Chairman Gonsalves stated there needs to be lighting in both Joe Eakes Park and the Corral in the parking areas added. I am asking Council's permission to discuss this with Progress Energy.

MOTION — Commissioner Swearingen made the motion for the SLAP committee to investigate with Progress Energy the possibility and cost of lighting in Joe Eakes Park and the Corral parking areas.

Extend boardwalk south of Atlantic Avenue

Chairman Gonsalves stated he isn't sure about the legal status of extending the boardwalk south of Atlantic Avenue.

Town Attorney Canoutas stated that maps are like treasure maps. Mr. Pilcher's legal description overrides the 1947 recorded map, which has never been used. Council would have to get Mr. Pilcher's approval for an easement for the boardwalk to be extended. Additionally, in 1995, the Town got beach renourishment easements. The property owner can't impede anything that will bring that project to a halt. Some of those easements were in the high water mark. Because of erosion, the fill was done by hydraulics. This was done by public funds. As per 146-6f of the North Carolina General Statutes, any project undertaken on the beach front where hydraulics are used to gain land belongs to the sovereign state of North Carolina. Extending this boardwalk is a bug-a-boo of problems. It will never happen, not in my lifetime.

Mayor Lambeth stated he read the statute with Andy (attorney) and it is pretty black and white. Unless we are willing to spend a tremendous amount of money, we will be spinning our wheels a long time.

Attorney Canoutas stated that Lee Wrenn reminded me that when people signed easements they were concerned that the Town would put something out there and that Council assured them they wouldn't. The dignity and respect of the Town is at stake.

Public Works Department

Public Works Director Beeker stated that you might have read about the water situation that Carolina Beach is in and I will be glad to answer any questions you have.

My recommendation is to keep doing what we are doing and not join Carolina Beach in purchasing water. We are in pretty good shape.

Free bulk trash pickup will probably be the second week in April and we will need to advertise. I will set the actual date.

1. Update on Ocean Front Park

Town Clerk Avery stated we are in the permitting phase with the storm water permit and are waiting for permit approval. Once we receive that, we will apply for a CAMA minor permit. Once that is received, we will issue the Request for Proposal for a contractor and break ground in late April or early May.

- 2. Strategic Plan: Where do we go from here? Commissioner Swearingen stated:
 - We have to take a strategic plan in baby steps.
 - We have not finalized a mission or vision statement.
 - I recommend waiting until we finish the budget sessions to talk about vision statements.
 - I want us to look seriously at a mission statement. Chuck (Keener) and Jim (Dugan) both submitted one and we talked about them and revised them. I gave everyone a report of the session. I want to know if a couple of Council members should get together to finalize the mission statement. Or would you like for me to finalize one. What is Council's pleasure?

CONSENSUS - Commissioners Swearingen and Dugan to work on a mission statement and present to Council.

DISCUSSION AND CONSIDERATION OF NEW BUSINESS

1. Communication between Council members

Commissioner Swearingen stated I know I'm the new kid on the block. This hit home while doing the strategic plan. I need to know from the four other Council members, what is your preference when I need to get something to you? Is it better to put it in your box or email it? At what point do I need to call you and say check your box or email, which still hasn't been done. We haven't read the agenda packet until a few minutes before the meeting starts. What is the best way for Council to communicate with each other?

Mayor Lambeth replied he prefers contact by the telephone. Mayor Pro Tem Keener stated his preference is email. Commissioner Nelder said he prefers telephone contact.

Commissioner Swearingen stated I need to know about the Polar Plunge on Saturday. Who will be there?

Commissioner Nelder said I plan on being there. Mayor Lambeth said I am not feeling well, so I'm not planning on it. Mayor Pro Tem Keener said I'll be there.

2. Extension of WAVE bus service from Wilmington to Kure Beach Mayor Lambeth stated extending WAVE bus service from Wilmington to Kure Beach was discussed at the MPO meeting. I asked why Brunswick County has WAVE service and we don't. Chairman Barfield stated we could have it, but we would have to contribute. I think we should go to the County Commissioners and state we are paying

enough in taxes and we shouldn't have to pay for bus service. I want a Council consensus.

CONSENSUS – let sleeping dogs lie until they make a presentation about WAVE service.

3. Attendance at NLC Conference Commissioner Swearingen stated:

- No one from Kure Beach has attended since Betty (Medlin) was mayor.
- Carolina Beach is a member of the National League of Cities and they are going to this conference.
- A considerable number of small towns in N.C. do attend this.
- I hope President Obama understands beach renourishment is an earmark.
- I want to know first hand what is happening and talk to our delegation about our priorities.
- I feel it is valuable to network with other small towns as to how they are handling things. There is a workshop for small towns at this conference.
- I can attend without the Town joining the National League of Cities.
- The approximate cost for me to attend is \$1,700.
- I would like to attend, but there is no travel money left in the budget. The money was spent on the Disc Golf Course and employee luncheon.

Discussion:

Attorney Canoutas stated I attended years ago when I was Carolina Beach's attorney. I also attended for Kure Beach. The Town paid part and I paid part. It is interesting and you learn a lot. It would behoove you to make arrangements ahead of time with your congressman to tell about your concerns about renourishment. They will meet with you there.

Mayor Lambeth said I had planned on going to Washington with the Carolina Beach mayor. As far as communicating, I always get a response or we can set up private meetings. I think we can spend the \$1,700 somewhere else. I will pay my way.

Commissioner Nelder asked if it is a worthy undertaking. We don't have money in the budget. It is not a good example to set for the rest of the Town, especially if we are looking at any possibility of a tax increase.

Finance Officer Copenhaver stated there are ways to do budget amendments. We have some revenue sources where we have exceeded budgeted amounts.

4. Request from property owner Jacqueline S. Wade to remove existing utility easement at 535 S. Fort Fisher Boulevard

Mayor Lambeth stated I was contacted by this owner about putting in a swimming pool at this address and I am recusing myself from this discussion.

Attorney Canoutas stated that Lawrence Kure put that easement in there. It runs two and one half blocks and is ten feet wide. It runs between lots on the waterfront. I always maintain that unless the Town absolutely has to, the Town should never get rid of any property it has.

MOTION - Commissioner Nelder made the motion to send a letter to the homeowner that the Town won't release the easement.

SECOND - Mayor Pro Tem Keener

VOTE – Unanimous

Mayor Lambeth recused himself from the vote.

5. Finance Officer Copenhaver

Mayor Pro Tem Keener stated he recommends the following for Finance Officer Copenhaver who was hired June of 2010:

- Removal of six month probation
- Annual salary increase of \$2,000 retroactive to December 29, 2010
- Paying for transfer of his CPA license to North Carolina

Finance Officer Copenhaver stated it would cost less than \$500 to transfer his CPA license to North Carolina.
