

TOWN COUNCIL ACTIONS

Regular Meeting
June 17 and 20, 2014

COMMITTEES

- Accepted John Gordon's resignation from the Stormwater and Environmental Committee.
- Accepted Tom Moffitt's resignation from the Stormwater and Environmental Committee.
- Accepted Mo Linquist's resignation from the Stormwater and Environmental Committee.
- Council voted to dissolve the Stormwater and Environmental Committee.
- Council directed the Town Clerk to communicate to all Town volunteers that it is important as community representatives to follow the guidelines of the Town regarding no alcohol consumption on public property. She is to include that, if committee members can't follow the Town's ordinances during events, they can't continue to be on a Town committee.

COUNCIL/LEGAL

- Council directed the Town Clerk to ask Public Works to install speed bumps, a stop sign at the parking lot exit onto South 3rd Avenue, and a "No Overnight Parking" sign, as soon as possible, regarding the new parking lot located between Fort Fisher Boulevard and South 3rd Avenue. She was also directed to speak to the Police Chief about increasing police presence and parking an unused cruiser in the lot on weekends, as well as putting in a right-turn only exit onto Fort Fisher Boulevard; and she is to speak to the Fire Chief about wetting down the parking lot to prevent excessive dust.
- Council directed the Deputy Town Clerk to send Linda Hutchins, resident on South 3rd Avenue, a set of minutes from the meeting so she can see that Council is addressing the problems at the parking lot.
- Council adopted the proposed amendment to Chapter 19 Zoning, Article III RA-1A Residential District, Division I Generally, Section 84 K Avenue Mixed-use Overlay District, to add subsection E(5)h regarding illumination.
- Council directed Mayor Pro Tem Bloszinsky and Commissioner Heglar to meet with Representative Ted Davis, Jr., in regards to a comment made about paid parking in Kure Beach.
- Council voted to cut the Marketing Committee's budget of \$141,480 by ten percent.
- Commissioner Heglar agreed to direct Public Works to continue to meet requirements to conduct storm water educational programs for residents and to provide educational literature for residents and for rental homes in Kure Beach.

FINANCE/BUDGET

- Council approved paying a \$936.25 invoice from Southern Signs for printing 6,500 beach brochures, to be taken out of the committee budget.
- Council approved Budget Amendment 14-11 to move \$1,000 from the Community Center Rental Fees to pay for maintenance expenses for the Community Center.
- Council adopted the FY14-15 Revised Budget Ordinance and Fee Schedule, as presented.

ORDINANCES/RESOLUTIONS/PROCLAMATIONS

- Council adopted Resolution 14-07, supporting a \$160 million local bond referendum to construct additional New Hanover County school facilities, renovate existing facilities, improve safety and security and upgrade technology.

NO ACTION/FOLLOW UP/TABLED

- Council would like the Planning and Zoning Commission to continue to look into the details of having a rental home certification requirement in Kure Beach.
- Council will postpone any work on the corral parking lot until Fall 2014.
