DISCUSSION AND CONSIDERATION OF DEPARTMENT HEAD BUSINESS

1. Fire Department

Fire Chef Kennedy stated the Fire Department will be taking 4 lifeguard stands off the beach strand for approaching Hurricane Erin and will take off the tops off all the rest of them. The plan is to have them all back on the beach for the weekend.

2. Police Department

Police Chief Bailey commented the Town did receive the DOT permit for the new radar speed signs and have been purchased and delivered to Public Works. They will be installing 5 new radar signs that will be replacing the existing traditional speed limit signs. The location of the new speed limit signs will be at: Corner of K and 5th Avene, 400 Block of South Forst Fisher BLVD, 300 Block of South Fort Fisher BLVD, Corner of North Fort Fisher BLVD and N Avenue, and another on the other side of the road at the Corner of Fort Fisher and N Avenue. Currently under budget in the amount of \$7000.00 for the purchase of these signs.

DISCUSSION AND CONSIDERATION OF OLD BUSINESS

1. Continued Discussion of the Purchase and Placement of the Sign for the German U-Boat Firing on Ethyl-Dow Chemical Plant in Kure Beach

Mayor Oliver stated included in the agenda packet is a sample sign that Wilbur Jones would like installed and the estimates of the cost of the sign. He included the verbiage he is recommending to be placed on the sign. He will open this up for discussion. The sign would be placed along Atlantic Avenue.

MPT Heglar stated he supports the sign, but the verbiage needs to be reviewed. This event has been talked about his whole life, and he thinks a replacement sign is fine.

Commissioner Panicali stated the language does need to be reviewed but he supports it.

Commissioner Ellen commented he supports it.

Commissioner Mearkle stated she would work on reviewing the verbiage for the sign.

2. Continued Discussion of KBC 11.20.010 Oceanfront Deck Encroachment

Director of Development and Compliance White commented last month discussed KBC 11.20.010 and Council directed her to follow up with other Towns on how they handle the easement and the of majority of Communities just follow the CAMA regulations. She drafted up an ordinance for Council to review that is a little more restrictive since it is the Town easement and Council may want to protect it. The current ordinance states "No more than two hundred and fifty (250) square feet of single-level, freestanding, uncovered deck, which does not include the walkway to the beach, and may not encroach more than fifteen (15) feet. This would apply to lots where the CAMA sixty (60) foot setback is within five (5) feet of the perpetual easement line. All proposed construction will also be subject to all CAMA guidelines. Should any encroachment extend into the Perpetual Beach Storm Damage Reduction Easement area granted to the Town, then and in that event, it shall be subject to the terms of the easement and as such is subject to removal at the owner's expense. Such removal shall be at the discretion of the U.S. Army Corps of Engineers for beach renourishment purposes." So, the issue with the current ordinance is that the Town does not use the development line anymore and CAMA regulations have changed. She has drafted the new ordinance to reflect the new CAMA regulations which limit no more than 200 feet of single-level, uncovered deck. An additional concern that came up was the height and CAMA does not restrict height on beach access ways or decks. So, she also included "with and equal in height to the beach accessway, but only landward of the pre-project vegetation line".

MPT Heglar stated if a property owner wanted a deck that was ground level, but the beach access was up, the way it is written it wouldn't be allowed.

Director of Development and Compliance White commented she can revise it to state "no higher than".
