OLD BUSINESS:

- 1. TDA Project. Dick Graham reported the web site was working well*
- 2. Coral Parking, Tony Gonsalves. Tony reported that Council asked that this project be put on hold until the Sept or Oct.*
- 3. J – E Beach Access parking, Jim Smith. This project is on hold*
- 4. Re-define parking spaces on Ft. Fisher Blvd. Jim reported this project is on hold.*
- 5. Sea Oats, Mike Bledsoe. Mike reported the sea oats were doing fine and no new one were required at this time.*
- 6. Keep America Beautiful. Susan Walters. Susan reported that Jennifer was no longer involved with this project. She contacted Adrian Moore who advised the beach sweep is scheduled for Oct. 4th at 9 AM. Susan will be the site captain for Kure Beach.*
- 7. Turtle Nests, Susan reported that at this time there are no turtle nests in Kure Beach.*
- 8. Brochure update, Kerry Garrigan. Kerry reported the brochures have been paid for and are available for distribution. Kerry and Susan have contacted the various Real Estate people and Home Owners association in Kure Beach and Carolina Beach to cover all entities who rent Kure Beach Properties. They have received very positive input from them. They have received requests for the list of activities for Kure Beach. These are available from the Chamber of Commerce and from the Town Hall.*
- 9. Trash pickup schedule for the beach. Steve Pagley will get the schedule for the pickups and advise the committee.*
- 10. K Ave Cross Roads signage. This project is complete.*
- 11. New Parking area. This project is complete for this year. There have been some small problems that have been addressed. The parking will be available for the balance of the year unless the property is sold.*
- 12. Goals for 2014 and 2015 are the same.*

NEW BUSINESS:

- a. Alcohol at the Ocean Front Park. The Town has an ordinance banning alcohol being consumed on Town Property. One of the functions has been a Wine Tasting that has received a Special Permit. All other consumption of alcohol is banned.*

The Committee has been advised that committee member Beth Yaccarino will be leaving the committee as she is relocating to South Caroline. Her resignation is en-route to Council. The committee would like her resignation effective at the next Town Council Meeting along with the upgrading Linda Cheshire from Alternate to permanent member. Committee member Clifton Beasley will be forwarding his resignation to the Council and if the council received it in time the Committee would like it to be effective at the next Council meeting. Chair Gonsalves has conducted a telephone conference to all committee members who have approved this request.
