V. OLD BUSINESS:

A. Parking on Hwy. 421

• SLAP Chairman Tony Gonsalves stated that there is nothing in the ordinance addressing parking or placing signs on right of way for those using public beach access

- Enforcing violators if signs are posted seems to be an issue
- Resident stated he addressed Council previously and spoke to representative from DOT who stated DOT would put up signs, but would need approval from the town.
- The process needs to be verified.
- Council can make a recommendation
- The town cannot stop public from using beach access.
- The question is, will placing signs on 421 be seen as stopping public from using access? Interpretation question.
- The signs are to prevent parking in right of way not preventing public from using the access.
- The parking issue came about because rental home occupants parking illegally.
- Attorney Eldridge believe parking can be regulated. It will take a talk with DOT to see how best to handle signage.
- Will police and Council allow signs?
- Will signage affect only the area by Ocean Dunes on the grass or all of 421?
- There are several issues; parking on grass by Ocean Dunes, excessive parking by rental units over occupancy on front lawns and empty lots, illegal parking all along 421 on private property, right-of-way issues.
- Town needs to find out what we can do and who has authority to post and enforce signs and what will be regulated

Member Whitley volunteered to conduct further investigation, contacting DOT and CAMA if necessary.

MOTION: Chairman Galbraith moved to table discussion of parking on 421 to find out what

authority the Town would have until the December meeting

B. Rental Certificates

Chairman Galbraith presented a draft based on other beach communities for review and discussion at later time.

C. Sea View subdivision

Chairman Galbraith attended Council meeting where the topic was presented as administrative process and was approved pending submission of further details by developer.

- There was a question about fencing around the retention pond
- This is an administrative process for P&Z to make recommendations to Council but did not have any discretion for approval
