VI. OLD BUSINESS

Beach Safety and Conservation Standards

Council accepted the recommendation with the two minor revisions from P&Z, and will hold a public hearing prior to their regular meeting on September 20, 2016.

Member Galbraith brought up the correlation between the quality of planning and zoning and economic development and tourism, of end of the tourist season, does anyone know how the City did concerning tourism. The more attractive a community is, the better they do in tourism and it bears out as well in Kure Beach.

A. Alternate Member

John Cawthorne was not present to be sworn in as an alternate Member approved by Council. There was discussion regarding what the status of an alternate member is and what the Council's intentions are.

- It would be expected that the person should be fully aware of the issues if they are going to step up in a member's absence on any given month and vote.
- It was not the understanding that the alternate would jump in if a member was absent from a meeting
- In the past, an alternate member was brought in when a member resigned and is replaced
- Councilman Joe Whitley will present to Council for verification of the status of the alternate at the next Council meeting.

B. Presentation by Suraiya Motsinger from the Wilmington Metropolitan Planning Organization (MPO)

- One of the major issues is funding for transportation 1970 Fed. Highway Act
- MPO projects are 80% funded by Federal and municipalities contribute 20%
- The current Plan extends to 2040 and is looking at trends
- MPO's are formed by the Federal government according to population, considering demographics, land use and travel patterns, where jobs are and where jobs will be in the future, with heavy emphasis on community involvement
- State Transportation Improvement Plan (STIP) decides which programs get funded

The various Modes analyzed Aviation
Bicycle and pedestrian
Ferry
Freight/Rail
Mass Transportation
Roadways

- The mission is trying to make the existing systems more efficient
- MPO developed base line date from census, state information, regional jobs analysis, land use planners, school systems, and where development was going in the future and has worked with the Port of Wilmington
- There are fiscal constraint requirements

#1 Develop - comprehensive, mode-specific, project list

#2 reduce list by - applying base, scenario projected funding

#3 increase list by - adding alternate funding

Projects are prioritized according to mode specifics looking at safety, traffic impact, and a project is rated using specific criteria, funded projects vs. unfunded projects. Every mode has different criteria and is weighed differently. Three different boards review the specific modes using sample projects using their "value judgment."
