Ottis White stated he is requesting the Town Council to adopt the Proclamation as presented. We have been promoting boating safety for the past 75 years. 80% of deaths on the water are caused by drowning where 86% of drowning cases, the victim was not wearing a life jacket. If someone crashes into your boat, you will not have time to put on a life jacket so it should be on the entire time.

4. Stormwater Oversight Committee

MPT Heglar stated the Stormwater Committee meeting has been moved to 6:00 pm on Monday, May 5, 2025. At the last meeting received a petition that was forwarded to all of Council from the former Hamlet beach area. He wanted to respond but was waiting on feedback from the Town Council before he responds. The Town is working on the outfalls as there were 3 significant issues from the residents and it is included in the budget for next year. He is working with the Mayor with NCDOT to work on the other outfall at Alabama Avenue.

4. Public Works Department

Public Works Director Mesimer stated regarding the paving contract he is meeting with the engineering consultant on Wednesday for an update. The outfall for H Avenue is complete and will be moving to J Avenue.

MPT Heglar stated Town Council needs to discuss the beach trash. The Public Works Department sent an email for input from the Town Council regarding the beach cans. He has requested email addresses of the HOAs and feels the department is prepared so just waiting on the input from Council so they can communicate with the HOAs and residents and order signs.

Mayor Oliver commented he is supportive but there will be some struggles to begin this change.

5. Recreation Department

Recreation Director Keely stated she received a Special Event Permit after the agenda packet was published for a Skim Board Competition on June 14, 2025 on the beach strand. The Kure Beach Peir is the supporting sponsor of the event. The applicant has been informed they must have insurance and also have to have ocean rescue personnel. The Recreation Department feels it is necessary to have Ocean Rescue personnel at the event.

Fire Department Kennedy stated he had commented due to the small number of members attending the event he did not feel it was necessary. It is a Skim board event that is right on the shore and the lifeguard would be in the stand near the event.

Mayor Oliver commented he does worry if a member of the event fell and hit their head, it would take the lifeguard away from his stand. He does feel it could be a liability to the Town. He is worried about this event happening during the Towns' busy season.

Commissioner Mearkle stated she supports having a lifeguard.

Commissioner Ellen stated he thinks an EMT should be at the event during the participating hours.

Commissioner Mearkle stated she learned that to sell license plates with the Town logo she would need approval from Town Council.

Recreation Keely stated the Town would have to purchase the license plates. The Town store does not offer to sell license plates. In 2012, the Town bought 500 license plates for \$5.00 a plate but now it would be \$15.00 a plate. The license plates were sold at a loss and given away as gifts to get rid of them.

Commissioner Mearkle commented she would look into different estimates and bring further information to the next Town Council meeting.

Good evening Honorable Mayor Oliver, Council Members,

Just 2 things tonight.

First, I just want to take a moment to thank you all for recognizing May as Bike Month with your proclamation.

National Bike Month has been rolling strong across the country every May since 1956, thanks to the efforts of the League of American Bicyclists. This annual tradition is more than just a celebration of biking— and it's not just about bikes—it's about what bikes represent: cleaner air, healthier people, fewer cars, and way more fun.

By issuing this proclamation, you're showing your support for those values and helping to encourage more residents to see bicycling as a viable, everyday option—whether for recreation, commuting, or staying active. It also sends a message that you're showing support for safer streets, sustainable transportation, and the wellness of our whole community. And maybe even giving a little nod to folks who ride their bikes instead of fighting over parking spots.

Through the WMPO's GoCoast program, we'll once again be encouraging locals to track their bicycle miles during May to show just how much biking is part of our everyday lives. It's a great way to see just how many of us are out there pedaling around—and it's not just because gas is expensive. There will also be safety tips, local events, and resources available on the GoCoast Bike Month webpage at https://www.gocoastnc.org/bikemonth/ and we will also post this on the Kure Beach Bike Ped Committee website.

Thank you again for your support and for helping to build a more bike-friendly, connected, and and vibrant community.

Secondly, a resident brought to our attention that there are currently no signs indicating that bicycles are not allowed on the boardwalk. This is confusing, since bicycles can legally only travel *north* on Atlantic Avenue with a rider. While many cyclists are respectful, clear and friendly signage could go a long way in preventing confusion and helping keep the area safe and enjoyable for everyone.

Especially during the warmer months, when the boardwalk is full of pedestrians, it's important for everyone's safety that cyclists are aware they're not supposed to ride there. It's a small thing, but it could really help keep the peace—on two wheels and two feet alike.

We're not looking for anything harsh—just something friendly, welcoming, and clear that fits the character of our town.
