### COUNCIL/LEGAL

- Directed Public Works to stripe the first parking spot to the south east of the pier on Atlantic Avenue as ADA per the Code of Ordinances
- Sent proposed amendments to Chapter 19 (Zoning) of the Code of Ordinances, Section 339 (Minimum parking requirements), Subsections 1 (Any residential use) and 2 (Multiple Family) regarding number of vehicles that may be parked on a property at any one time back to P&Z for more clear direction on:
  - What problem is this solving?
  - Is this complaint driven?
  - Does it apply throughout town on all properties and if not, then where?
  - Does this apply only to new construction?
  - What is the enforcement mechanism and how will that work?
- Approved setting up standing committee for naming town public buildings, memorial benches and donations to consist of two Council members and three other members selected by Council

### FINANCE/BUDGET

- Approved R18-08 approving financing terms with BB&T for 2018 GMC Sierra 2500 in the amount of \$40,400 at 3.86% for four years for Public Works service truck

### FOLLOW UP

Parking

- Mayor to communicate with HOAs for input on which streets in developments with width of 26 feet may have marked designated parking spaces on one side only with an end date for feedback of August 14 by 5 pm
- Ocean Dunes ROW– Mayor to work with Police Chief and Public Works Director on marked parking spaces near public beach accesses
- P&Z member Ken Richardson and Commissioner Allen Oliver will start process of identifying potential new parking spaces on 421 (FFB) and in neighborhoods and have P&Z review before bringing to Council
- Potential designated parking spaces on E, I and 6<sup>th</sup> Avenue medians needs to be reviewed and approved by P&Z to make sure in compliance with ordinances before coming to Council
- Residential stickers – Council needs to understand from the attorney if these may be used for parking and how that process will work
- Mayor will get input on possible restrictive spaces to be marked as no parking
