COMMITTEES

- Appointed Barbara Boal to the Kure Beach Community Center Committee.
- The Parks & Recreation Advisory Board will pursue finding outside vendors to submit proposals to hold an event similar to the annual Triathlon. The board will review the proposals and recommend one or two vendors to Council for further discussion. Parks & Recreation will suggest the best dates on which to hold the event.

COUNCIL/LEGAL

- Council gave the Building Inspector the latitude to pursue cleaning up the lot located at 409 F Avenue, according to Town ordinances.
- Council denied the 2013 Triathlon permit application from Set Up Events due to non-payment of 2012 Triathlon fees.
- Council requested a certified letter be mailed to Bill Scott of Set Up Events stating that, based on non payment of 2012 Triathlon fees, Council is denying his application to hold a 2013 Triathlon and will not reconsider issuing the 2013 permit.
- Council adopted the 2013 Town Holiday schedule.
- Council voted to not put up a foot washing station at the I Avenue beach crossover.

FINANCE/BUDGET

- Approved the Beach Protection Committee's request to spend \$75 from the committee budget to purchase supplies and drinks needed for the New Hanover County Beach Sweep to be held on September 29, 2012.

PROJECTS

Bike Path/Greenway

- Council will sign a document along with Carolina Beach in support of the Greenway Plan throughout Pleasure Island as is shown on the maps provided by the WMPO Greenway Planning Committee.
- Mayor Lambeth said he would talk to Carolina Beach Town Manager Tim Owens about drafting the document approving the Greenway plan for Pleasure Island. The letter will be given to the Kure Beach Council members to review and approve before the Mayor signs it.
