- Scheduled a public hearing for Tuesday, April 17 at 5:30 pm regarding the concept of paid parking in Kure Beach.
- Scheduled a public hearing as the first item of business on the regular Council agenda for Tuesday, April 17 at 6:30 pm regarding a draft ordinance on "Alternative Energy."

FINANCE/BUDGET

- Approved application for TDA reimbursement of \$3,300 for the 2011 Kure Beach Fantasy Christmas Show.
- Approved application for TDA reimbursement of \$8,000 for 2011 Pleasure Island Chamber of Commerce Free Summer Concert series.
- Approved spending \$1,050 out of the Fiscal Year 11-12 Committee budget to purchase Sea Oats from Carolina Beach.
- Approved the contract from VC3 for \$16,200, to design a new website for the Town; \$8,100 to be paid from the current Fiscal Year 11-12 Admin & Finance budget and \$8,100 to be paid from the Fiscal Year 12-13 Admin & Finance budget.
- Authorized Finance Officer Copenhaver to use leftover balance of \$11,561 from the NHC Park Bond Referendum funds, as follows: \$4,000 for a concrete tennis backboard for the tennis courts, \$500 to be used by the Beautification Committee for gardens and the remaining balance to be used for the Ocean Front Park.
- Approved contributing \$1,000 to the Ports, Waterway & Beach Commission to be taken from the Fiscal Year 11-12 Governing Body Governmental and Volunteer Relations line item.

- Authorized Town Clerk to mail a letter to adjacent property owners requesting their input into Council's intent to mark six parking spaces with concrete bumpers on the southwest corner of E Avenue, at Ft. Fisher Boulevard. Readdress at April Council meeting.
