# GENERAL OVERVIEW

Performs a variety of responsible skilled and semi-skilled maintenance, repair, and construction work on streets, buildings, grounds, water and sewer lines and appurtenances.

## **SUPERVISION**

Work is performed under regular supervision and is evaluated through observation and inspection for adherence to instructions and standard trade and safety practices.

#### **ESSENTIAL FUNCTIONS**

- Operates construction equipment such as back hoes and loaders in tight spaces around parked cars and overhead limbs and utilities, and underground utilities; operates tapping machines to make water and sewer taps; operates dump trucks, loaders, tampers, trenchers, air compression driven equipment, and other related light and medium equipment; performs preventive maintenance and minor repairs to equipment; may serve as lead worker.

- Performs semi-skilled trades work in the construction, replacement and repair of water and sewer lines; uses shovels to finish grading trenches for construction of water and sewer lines; fits pipe; uses hand tools and operates equipment to back fill trenches.

- Cleans stopped sewer lines with rods, rakes, and shovels.

- Participates in making water and sewer taps and installing fire hydrants; reads, installs and replaces water meters; connects and disconnects service.

- Checks for and repairing leaking lines; performs maintenance and repairs on valves; assists with reconnecting water service.

- Participates in the operation and maintenance of the wastewater plant; greases and repairs equipment; programs spray field equipment; takes readings from gauges and meters; takes samples and performs simple standardized tests; prepares and maintains records of work activities.

# **ESSENTIAL FUNCTIONS (cont.)**

- Participates in asphalt and concrete repair to streets, sidewalks, curb and gutter and other street facilities; fabricates and erects street signs.

- Repairs, builds and cleans storm sewers, catch basins, driveway pipes and aprons. Participates in mowing, mulching, planting, irrigating, and other landscape maintenance tasks.

- Cleans buildings, paints, replaces light bulbs, arranges furniture, repairs roofs, walls, and other minor carpentry, plumbing, and electrical work; performs other semi-skilled and unskilled building maintenance and repair tasks.

- Performs a variety of unskilled, semi-skilled, and occasionally skilled labor tasks in the construction, maintenance, operation, and repair of water and sewer lines and appurtenances, wastewater treatment plants, streets, sidewalks, drainage systems, buildings, grounds, and other facilities.

- Operates light, medium, and heavy equipment with skill to build, repair and replace sections of water and sewer lines, streets and other infrastructure.

- Works in both inside and outside environments, in extreme hot and cold weather, and exposure to various hazards such as loud noises, vibration, moving mechanical parts, electrical current, chemicals, fumes, odors, dusts, mists, gases, poor ventilation, and oils

- Works in water or sewer pipes and man holes. Work around raw sewage is also subject to the final standards of OSHA on blood borne pathogens.

- Subject to on-call and call-back work.

- Performs other duties as assigned.

#### **KNOWLEDGE, SKILLS, AND ABILITIES**

- Considerable knowledge of tools, materials and equipment used in public works and utility construction and maintenance work.

- Considerable knowledge of wastewater collection system, and/or water distribution system principles and practices.

- Working knowledge of the Town's utility customer service policies and procedures.

- Working knowledge of the occupational hazards and safety precautions of the work.

- Working knowledge of municipal maintenance and construction practices.

- Working knowledge of traffic laws, ordinances and regulations pertaining to operations of motorized equipment.

- Skill in the operation of heavy equipment.
- Ability to understand oral and written instructions.

- Ability to establish and maintain effective working relationships with citizens, supervisors, and other employees.

- Ability to prepare simple written records of work activities.

# EDUCATION AND EXPERIENCE

- High School diploma or GED required

- Experience in semi-skilled maintenance or construction work, including heavy equipment operation, which provides the required knowledge, skills, and abilities; or an equivalent combination of education and experience.

## SPECIAL REQUIREMENTS/CERTIFICATIONS

- Require possession of distribution system, Wastewater system, or collection system operator certification.

- Possession of a valid North Carolina commercial driver's license.

#### PHYSICAL/CRITICAL REQUIREMENTS

**Physical Ability** 

- Must be able to physically perform the basic life operational functions of climbing, balancing, stooping, kneeling, crouching, crawling, reaching, standing, walking, pushing, pulling, lifting, feeling, talking, hearing, and repetitive motions.

- Must be able to perform heavy work exerting up to 100 pounds of force occasionally; 50 pounds of force frequently; and 20 pounds constantly.

**Visual Ability** 

- Must possess the visual acuity to operate mobile equipment such as the loader and dump truck in a safe manner.
